- Tom Dempsey went over the Month End financials.
- The Check Detail report was reviewed by David Wahlstrom. It is in order.

## **CAPITAL RESERVE:**

• David Wahlstrom had no Nov 2020 meeting minutes. He did go over several projects that were completed in 2020 and others that will be completed in 2021, per our Capital Reserve Study.

#### **EXTERIOR FACILITIES/MAINTENANCE:**

- There are ongoing draining issues in Unit 56. The Homeowner paid for the repairs but it has been
  determined that a water line to the street must be replaced. A MOTION was made by David Wahlstrom

# **OLD BUSINESS:**

- A debit card (funds withdrawn from the Checking acct) has been issued and Linda brought up the fact that if it is used for purchases that we need to insure there are funds in the account. Small items won't require this but a Vendor may run the card and funds could be withdrawn. We just need to insure funds are in the account prior to use. Steve Alley said that the card will not be used for large Vendor purchases.
